In accordance with the Establishment of the Council on the Government Procurement Review (Cabinet decision of December 1, 1995), the operation of the Council on the Government Procurement Review (hereafter referred to as the "Council") shall be as outlined below.

### 1. Convening of Council meetings

Council meetings shall be convened by the Chairperson.

### 2. Government Procurement Review Board

The Board shall separately define other provisions necessary for Government Procurement Review Board operation.

### 3. Executive Board

- (1) The Executive Board shall be composed of the members indicated in the attachment.
- (2) Executive Board meetings shall be convened by the Secretary General.
- (3) The Executive Board shall strive to ensure smooth communication and coordination between related ministries.
- (4) The Executive Board shall coordinate with the Liaison Council for Ministries Involved in Voluntary Measures on Government Procurement (March 31, 2014 agreement between related ministries).
- (5) The Executive Board may make Council decisions with the approval of the Chairperson.
