

Inter-Ministerial Coordination Meeting on Well-being

1. Purpose

In addition to economic indicators such as GDP, it is highly valuable to focus on broader aspects of societal well-being, including people's quality of life, and life satisfaction. In line with the Cabinet decision of June 2021 on the *Basic Policy on Economic and Fiscal Management and Reform 2021*, which stipulates that “KPIs related to well-being will be set for various basic plans of the Government,” the Inter-Ministerial Coordination Meeting on Well-being (hereinafter “the Meeting”) is convened to promote coordinated efforts on well-being across relevant ministries and agencies.

2. Areas of Discussion

The Meeting will facilitate information sharing on Well-being-related policy measures within relevant ministries and agencies, strengthen inter-ministerial collaboration, and promote the dissemination of good practices, with consideration of the following perspectives:

- Establishment of Well-being-related KPIs in various government plans
- Advancement of statistics, surveys, research, analysis, and pilot projects related to Well-being
- Other policy measures that contribute to the promotion of Well-being

3. Composition of the Meeting

4. Secretariat
